

NOTICE OF COLLECTION: FEE 0

Marbella, 10 May 2018

PUERTO JOSE BANUS S.A. has the duty to inform you that, just as you were notified on 11 April, we are going to proceed to the collection of FEE O ("TASA O") for 2017, from Tuesday 15 May. During the second half of the year, we will proceed to levy the charge for 2018.

You can make this payment at our offices in Puerto Banús or by bank transfer.

Office hours: 9AM-2PM and 4-6.30 PM.

We would remind you that Fee 0, or the 'Navigation Aid Fee', is imposed by the Málaga Port Authority, and not by Puerto Banús.

What is the fee T-0?

Port fees are defined to be those demanded for the exclusive or special utilisation of public port areas, and for the provision of non-commercial services by the port authorities.

In the case of Fee O, which is regulated by the National Ports and Merchant Marine Act, this was created for:

- The maintenance of the navigation aid services (lighthouses, maritime beacons, devices to enhance navigation safety, etc.), provided by the port authorities.
- The navigation aid services provided by the Spanish Maritime Safety & Rescue Agency ("SASEMAR").



Who has to pay the fee T-0?

- Leisure or sports vessels of length ≥ 9 metres if motor-propelled, or
 12 metres if sail-propelled
 - o Vessels based at a Spanish port: payment once per year.
 - o Vessels not based at a Spanish port: payment per day of stay.
- Leisure or sports vessels of length < 9 metres, if motor-propelled
 - o Vessels based at a Spanish port: a single payment at the moment of entry into force of the fee, or at the moment of registration.
 - o Vessels not based at a Spanish port: payment per day of stay.

How is the fee T-0 calculated?

The total amount of the fee T-O is the result of multiplying the basic amount by a coefficient determined by the length of the vessel, and by the area occupied by the vessel (length x beam), expressed in square metres.

Basic amount = Port Authority (0.29) + SASEMAR (0.28) = 0.57

Total amount = Basic amount x Coefficient x Length x Beam

When is the fee T-0 payable?

In the case of base at Puerto Banús (more than 182 days per year), the fee must be paid in advance according to the table in the previous section. At the moment of payment of the fee, Puerto Banús will issue a certificate accrediting this fact, for possible movements to other ports in Spain.

In the case of vessels visiting Puerto Banús, when your vessel enters the port, the amount of the corresponding fee T-0, according to the parameters established by law (set out in the table in the previous section), will be charged to you.

Should you have already settled the Fee referred to at another port in Spain, you need to furnish us with the corresponding certificate of accreditation from that port to prevent possible duplicate payments.
